PPA Meeting and Elections Changes

Due to the current pandemic, certain changes must be made to the normal operations of Prospect Park Association. A resolution has been voted on and approved by the board on June 22, 2020.

1. Prospect Park Association Meetings will be held virtually to meet safety guidelines. This will be in effect indefinitely.
2. 2020 Board of Director Elections will be held via Mail-In Voting. Details and sign-up for voting will be provided in August.
3. PPA's 2020 Annual Neighborhood Meeting will take place virtually. Annual Meeting scheduled for September 21, 2020.

Prospect Park Removes Eight 30-year-old Neighborhood Watch Signs

About 50 PPA community and board members met to discuss the motion: “PPA supports neighbors removing the eight neighborhood watch signs that read: *If I don’t call the police my neighbor will.*” In light of the killing of George Floyd, Breonna Taylor, and other Black Indigenous and People of Color (BIPOC) by police, most members agreed the signs should go. Our thanks to Prospect Park residents for raising awareness of the unwelcoming message and removing the signs. The motion to remove the signs was approved unanimously on June 22nd by PPA’s Board of Directors. It had previously been approved by the Transportation and Safety Committee. The motion addressed the eight signs and not neighborhood watch as a whole. The signs were located near Franklin Avenue on Bedford, Emerald, Sharon, Seymour, and East River Terrace.

PPA's Community Building Committee First Year Report

The PPA Board established the Community Building Committee on May 20, 2019. Its purpose was to provide leadership to PPA as it sought to improve its connections with individuals and groups of people with whom PPA had not been connecting well over the past few years. Community Building's initial focus was listening and connecting, ultimately meeting with well over 100 groups and individuals. The purpose was to find out what was on the mind of key people and organizations in our community from their point of view. We learned many things and discovered situations where we could be of help, especially in two key areas: residents of Glendale Townhomes Public Housing Community; and the large groups of renters living in Prospect Park including University of Minnesota students, and people living in the new developments north of University Avenue.

Council Member Cam Gordon Invites You to a Community Gathering on Proposed Reframing of Public Safety in The Minneapolis Charter

The killing of George Floyd by Minneapolis police set off a worldwide wave of protests, including an uprising here in our city that left hundreds of businesses and homes damaged or destroyed. It is clear that the status quo is broken, and that it is time to make a transformative change to the way that we approach community safety. I believe that we have a unique opportunity and an obligation to transform the way we provide for each other's safety this year in our City. The Council unanimously passed a resolution committing to do just that on June 12, stating that **“the City Council will commence a year long process of community engagement, research, and structural change to create a transformative new model for cultivating safety in our city.”**

As a next step, on June 26 the Council voted unanimously to put forward a Charter amendment, which I hope will be on this year's ballot.

This amendment, if placed on the ballot, will do a few major things. It will remove the Police Department as a Charter department, and replace it with a new Community Safety and Violence Prevention department, which will “have responsibility for public safety services, prioritizing a holistic, public health-oriented approach.” It will not preclude the City from continuing to employ licensed police officers, but will also not require us to do so. The law enforcement division, if we choose to have one, will report to the Community Safety department, and the director of Community Safety will appoint the head of law enforcement, with the Council's approval.

I strongly favor this change, which in my view is a necessary first step that will give us the flexibility we need to make the deep community engagement we will be doing on the future of community safety meaningful. Whatever the results of that engagement, and the path forward we all choose together, this Charter amendment will give us the ability to move forward.

I believe that it's time for that engagement to start now, so I am hosting a number of community gatherings to discuss the Charter amendment, answer any questions people may have, and discuss further how this might move forward this year. Keeping in mind that we are still in the midst of the COVID-19 pandemic, I will be hosting these meetings in neighborhood parks. Please feel free to join the meeting in your neighborhood, or that is most convenient for you. **Please remember to bring your mask, and expect to remain physically distant from other attendees.**

Remember: Counting Every Person Truly Matters

Missing just one person in the census will result in a loss of over \$27,000 of federal funding to the State of Minnesota over the 10 years, until the next census in 2030. Get counted! Prospect Park has an expected undercount of 2,500 people, **which**

could lead to the loss of \$67,500,000 that could be put directly into community funding.


